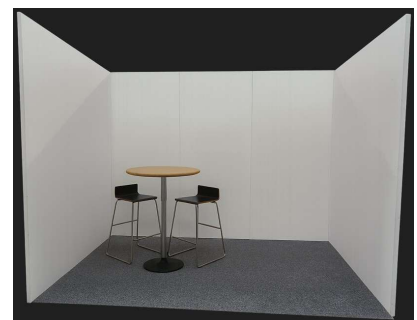

7 Recognition

If the forthcoming congress has to be cancelled due to official requirements in Switzerland, the registration shall be deemed cancelled without substitution. No claims can be made by either of the contracting parties after such a cancellation.

The organizer will not charge any processing fees and will refund any advance payments or payments on account made by exhibitors in full.

By signing, the exhibitor confirms that he fully and unconditionally recognizes the Rules for exhibitors of the venue¹⁾ as an integral part of this contract, which only becomes valid upon signature by the organizer, in particular the regulations concerning

- Conclusion of compulsory liability insurance
- Revocation of registration and withdrawal from the contract by the exhibitor: see below²⁾
- Right of revocation, removal and expulsion of the exhibition management
- Fire police and other safety regulations
- Control, instruction and intervention rights of the trade fair management

²⁾ Cancellation of the registration and withdrawal from the contract by the exhibitor:

If exhibitors withdraw from the contract after it has been concluded but before the event begins, they shall be liable to pay, in addition to a contractual penalty of CHF 1'000.-, the full stand hire fee and any ancillary costs incurred up to the date of withdrawal.

This applies regardless of whether the allocated stand space can subsequently be let to another party.

8 Place of jurisdiction for applicable law

The exhibitor recognizes St.Gallen as the place of jurisdiction for disputes arising from this contract. Swiss law shall apply exclusively.

9 Payment terms

Invoicing and debt collection are handled by Olma Messen St.Gallen AG, Spluegenstrasse 12, CH-9008 St.Gallen, Switzerland.

- Partial invoice³⁾: 100 % of the current obligation; payable within 30 days of the invoice date
- Final invoice: after the conference; payable within 30 days of the invoice date

³⁾ Exhibition fees must be paid no later than 14 days before the start of the conference. Otherwise, access to the exhibition will be denied.
